Previous Minutes

The minutes of the previous annual general meeting were accepted. Proposed: Andrew Robinson. Seconded: Ray Adams. Accepted with no objections.

Voting

It was agreed that all present at the meeting except Sarah Colwell were current financial members of the club and therefore eligible to vote on matters at this AGM. Two proxies were accepted, all made in favour of the chairman. With a quorum achieved the meeting could proceed.

Management committee reports

President's report / DOP Report

Andrew Robinson gave verbal summary. The following points were noted:

- Membership levels at the club has had a slight dip, with the club presently having 16 financial members made up of 14 seniors and 2 juniors.
- All tournaments are expected to be completed by the end of 2013.
- Participation in club tournaments remains steady.
- The tournament schedule is expected to remain unchanged in 2014.

Secretary/Treasurer's report

John Ryland gave a verbal summary and presented the financial statements. He drew the members' attention to a few key points:

- Income for 2012-13 was \$1695.40, which adequately covered the club's expenses of \$2120.51, after allowing for \$581.60 depreciation which formed a significant chunk of the expenses
- Expenses have increased slightly now that a new rent agreement has been signed with the school which charges \$22 per night for the use of the school facilities
- Despite this, the fee structure seems adequate to cover expenses into the next year
- Expenses related to bank fees have been reduced to nil since the club's banking accounts were moved Heritage Building Society
- John acknowledged and thanked Greg Colwell for his assistance in putting together the financial statements for 2012-13.
